a) **Period** This contract will begin on _____ and continue for: [] **6 Months** [] **12 Months**

b) **Rate** Customer has agreed to contract Database Whiz Consulting for a minimum set of hours each month at a discounted rate as follows:

The hours and hourly rates selected are referred to in this contract as Service Plan.

[] **A:** 5 hours per month at \$97.50 per hour / \$487.50/mo

[] **B:** 10 per month at \$80.00 per hour / \$800/mo

[] **C:** 20 per month at \$65.00 per hour / \$1300/mo

c) **Definition of Month** A month, as used in this contract, is a US Calendar month. i.e. January 1st through January 31st.

d) **Minimum Amount Due** Customer will pay at least the minimum amount of hours in the service plan, i.e.: If a 10 hour plan is selected and Customer does not have Database Whiz Consulting perform at least 10 hours of maintenance and service, Customer is still responsible for paying the 10 hour minimum. Hours do not roll over to the following month.

e) **Statements** Statements will be generated and emailed at the beginning of each month. Customer is expected to mail payment or pay online immediately upon receipt of the invoice. In the event full invoice payment is not received within 15 calendar days of the invoice date, Customer will forfeit their contract rate for that billing period and invoice will be adjusted to reflect Database Whiz Consulting's regular service rate. Additionally, Customer will be responsible for late fees.

f) **Additional Hours** **Billable hours that go beyond the agreed upon service plan will be billed at the rate of the service plan hourly rate.** i.e.: If Customer prepays for 10 hours of service at \$80.00 per hour, any hours after the initial 10 hours will be billed at the \$80.00 per hour rate. ****NOTE**** This discount for additional hours will be forfeited if bill for additional hours is not paid upon receipt and received in our office no later than 15 calendar days from the statement date.

g) **Contract Cancellation** This contract may be canceled by either party with 15 days notice in writing prior to the start of the next contract period. In the event that Customer wishes to cancel this contract, Database Whiz Consulting must receive the cancellation in writing, either by fax, US mail, or email to support@databasewhiz.com.

h) **Authorized Signer** This contract is only valid if signed and dated by a company owner or officer, with proper ID to be presented at time of signing.
